

Data Sharing Information

- **Important information about the sharing of your medical information**
- **Patient Opt Out / Dissent request form**

There are currently 3 DIFFERENT initiatives in data sharing;

- Summary Care Record (SCR) - *Coventry Road Practice have implemented this system, see next page for more information*
- Central care record (CCR) - *Coventry Road Practice do not currently offer CCR but may offer the functionality in the future*
- Care.Data - *currently on hold*

Patients need to consider **EACH** different data sharing initiative individually and decide whether they wish to take action and OPT OUT / DISSENT from the data sharing.

You have the right to prevent confidential information about you from being shared or used for any purpose other than providing your care, except in special circumstances. (NHS England)

Opting Out / Dissenting from data sharing will not affect the care you receive

Summary Care Record – Sharing brief medical information for better Emergency Care

Information Shared

- Name, address, date of birth and your unique NHS Number (to help identify you correctly).
- Allergies and Adverse Reactions, Acute Medication, Repeat Medication, Discontinued Medication in the last 6 months.

How will Summary Care Records help me?

- Healthcare staff will have quicker access to information about your medicines, allergies and adverse reactions
- Provide you with safer care during an emergency, when your GP practice is closed or when you are away from home (England)

Central Care Record – Joins together information held on various computer systems across Bham, Solihull and Sandwell

Information Shared

- Name, address, NHS number, allergies, medication, blood test results, measurements, diagnosis, treatment (either past or present) and any end of life wishes.

How will Central Care Records help me?

- It means that whoever you see in these areas will understand your needs more quickly because your information is in one place.
- Improves communication across local GPs, Hospitals and community services, avoiding duplication of investigations such as blood tests and also prevents patients from having to repeat their story.

- Both Identifiable (NHS Number, date of birth, gender) and Non-identifiable information will be extracted if needed
